"The right of any individual, firm, partnership, corporation or association supplying the contractor with labor or materials for prosecution of the work herein above stated to institute action in the penal bond pursuant to the provision of Act. 3688, is hereby acknowledged and confirmed"

WHEREAS, the Obligor requires a performance security in the above stated sum to secure the full and faithful performance of the obligations of the Principal under the contract within the period of (**One (1) Year**) as specified in the bidding documents/terms of reference pursuant to Section 39 of the Implementing Rules and Regulations of R.A. No. 9184 and an additional one year (1) coverage from date of completion up to final acceptance to guarantee that the above-bounden Principal shall undertake the repair works of any damage to the infrastructure on account of the use of materials of inferior quality discovered within the defects liability period pursuant to Section 62 of the Implementing Rules and Regulations of R.A. No. 9184.

IT IS UNDERSTOOD, that this bond is callable on demand.
