INVITATION TO BID

The **Technical Education and Skills Development Authority (TESDA)**, through the General Appropriations Act for the CY 2021, intends to apply the total sum of **Four Million Two Hundred Thirty Six Thousand Four Hundred Eighty Pesos Only (P4,236,480.00)** being the Approved Budget for the Contract (ABC) to payment under the contract as identified below for the provision of Security Services Requirements for TESDA-CAR (January 01, 2021 – December 31, 2021). Bids received in excess of the ABC shall be automatically rejected at bid opening.

TESDA now invites bids for the **Provision of Security Services Requirements for TESDA CAR (January 01, 2021 – December 31, 2021)**. Bidders should have completed, within ten (10) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly in Section II on the Instructions to Bidders.

Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184, otherwise known as the Government Procurement Reform Act.

Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the IRR of Republic Act No. 9184.

Interested bidders may obtain further information from the BAC, TESDA – CAR, Loakan Road, Baguio City and inspect the Bidding Documents at the said address at anytime between 8 a.m. to 5 p.m starting 13 October 2020.

A complete set of Bidding Documents may be purchased by interested Bidders beginning on October 13, 2020 from the address above-mentioned and upon payment of a non-refundable fee of **Five Thousand Pesos (P5,000.00)** for the Bidding Documents.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

TESDA will hold a Pre-Bid Conference on October 19, 2020 at 2:00 p.m. TESDA standard time at the TESDA-CAR Multipurpose Hall, Ground Floor, Loakan, Baguio City, which shall be open to prospective bidders.

Bids must be duly received by the BAC Secretariat, TESDA CAR Regional Office, Loakan, Baguio City, on or before November 04, 2020 at 2:00 p.m TESDA standard time. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in Instructions to Bidders Clause 18.

Bid opening shall be held on November 04, 2020 at 2:00 p.m. TESDA standard time, TESDA-CAR Regional Office, Loakan, Baguio City. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

TESDA – CAR reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award accordance with Section 41 of Republic Act No. 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
